## **Upper Long Lake Management Committee Meeting Minutes**

## Minutes follow the Agenda (see attached Agenda):

**Opening Remarks:** Ron mentioned that the agenda is full. The major topics included the depleted contingency fund, and the 2013 plan and budget, with all associated contracts, which will be signed by the Lake Board. Ron referred to the very detailed agenda and as we worked through each item we would record the financial impact on the 2013 worksheet, which is part of the agenda. When all items have been discussed we will add up all expenses and that will be our budget and plan.

Prior to the meeting Ron had sent four e-mails, with attachments, to prepare the attendees and neighborhoods for this meeting. The e-mails were "Management Committee Meeting Agenda Plus", "Lake Management Committee Meeting", and "Lake Management Committee Minutes from April 23, 2012" and "Our Lake Management Fund is Out of Money". Steve George, from the Woods, distributed the information around his subdivision. The President of the Woods, Gregg Leshman, announced that this topic would be addressed in their upcoming ULLWCA Homeowners Association Meeting on April 9, 2013. Sheldon Yellon, president of the Shores subdivision posted much of the information on their website. Ron is a ULLE representative to the Lake Management Committee, so he also sent ULLE acting-President, Amy Monroe, with all these e-mails and directives.

**Approval of prior minutes:** The 2012 minutes were distributed by e-mail prior to the meeting and copies were available during the meeting. The 2012 minutes were unanimously approved as published with little discussion. Several parties who were present during the 2012 Lake Management Committee meeting commented on the minutes' accuracy. All uncompleted action items will be carried forward in these minutes.

• All members to look for items that are bolded. They are action items.

## **COMMITTEE REPORTS:**

Administration: There are two years remaining from our five year program. Budgets and assessments are set for five years and if during that timeframe assessments need to be raised a public meeting will be held. Only the Lake Board can raise assessments. Our committee is a volunteer advisory group only. The assessments are not a tax. In error some SAD members have thought it to be a tax and therefore subject to the Headley Amendment and a vote of the members. However this is not the case according to the Bloomfield Township attorney (who has cited case law documenting the legal distinction between SAD assessments and taxes).

SAD assessments have remained unchanged for 12 years. In 2001 the assessments were raised for two primary reasons:

- 1. For the Lake Board to pay \$60,000 to build the ULLE Lot 64 harvest site which contained two ramps (one for harvesting, and one for residential use while harvesting is being done) for lake harvesting;
- 2. To cover the expenses of weed management of the lake, including increased weed tonnage and harvesting the lake three times per year instead of two harvests per year, and normal rate increases over time due to inflation with his process.

To note, there was discussion at this point on harvesting and Ron presented a chart which documented the Upper Long Lake Harvesting history (see attached). This chart analyzes and compares the Wittbold operation vs. current harvesting practices in terms of efficiency, effectiveness and cost. From 2001 to date the costs have increased from \$42,800 in 2001 (when the SAD rates were raised) to \$79,400 in 2012. This is a 85% increase. However the CPI inflation factor is approximately 31% from 2001 to date. The remaining 54% represents costs associated with the lake's increase in weed tonnage. Key considerations of Ron's chart:

- From 1988-2003 Wittbold's average yearly weed tonnage: 290.3 tons/year
- From 2004-2012 Inland Lakes' average yearly weed tonnage: 1,063.1 tons/year
- Thus, Inland Lakes harvests 366% more tons of weeds per year out of UL than previous harvester
- Wittbold's costs average \$102.20/per ton weeds harvested
- Inland Lakes costs average \$60.01/per ton weeds harvested
- Thus, in terms of cost Inland Lakes removes significantly more weeds from UL in a more cost efficient manner. Inland Lake is 70% more cost efficient than previous harvester (Wittbold) in terms of cost per tonnage.
- Wittbold's average number of harvest days from 1988-2003: 7.7
- Inland Lakes' average number of harvest days from 2003-2012: 9 days
- Thus Inland Lake takes only 17% more time on lake to do 366% more work, collecting 772.8 tons more weeds per year.

This was enlightening to attendees that Inland Lakes efficiency and effectiveness of harvesting was a significant improvement from previous harvester, Wittbold. It also affirmed the good opinion the overwhelming majority of residents have toward the good work Inland Lakes does for UL. These facts were contrary to the opinion of a very select few Group C residents stating Inland Lakes was not effective or efficient compared to Wittbold. Residents and attendees agreed Inland Lakes does good work and should continue as harvester. The discussion continued that since 2001, the assessments have basically been the same at \$389.14 for riparians and \$97.29 for access residents. In 2001 it was anticipated the assessments may decrease once the harvest site was paid for. However, there were unanticipated expenses the Lake Board covered since 2001:

- 1. \$63,769 for weir repair (which was a onetime assessment at that time of \$318.24 for riparians);
- 2. \$17,200 administrative fees from West Bloomfield. It was noted during the meeting that West Bloomfield charges a 5% administrative fee for all of assessments collected in West Bloomfield. This was an unknown expense until 2013 when research showed some financial discrepancies were due to this fee, and not due to residents not paying their SAD assessment,

as was previously thought. West Bloomfield does not line-item their deduction; they simply cut a check to the Lake Board for less. At this point, Bloomfield Township charges no fee for administering Upper Long Lake's SAD.

3. \$7,500 Lake Board legal expenses associated with the review of harvesting access agreements which the Lake Board was forced to develop last year due to the threat of access being denied to Lot 64 to the Lake Board by select ULLE members. As noted in the 2012 Lake Management Committee meeting when Jim Joseph stated as noted in the 2012 Minutes: "It was Jim Joseph's opinion that Inland Lakes and the Lake Board are in breach of contract as interpreted by Jim Joseph." Also during the 2012 meeting the following quote from the 2012 minutes is relevant:

"As it relates to reviewing alternatives to weed harvesting, Pete Filpansick, an Environmental Biologist was consulted on this subject during the meeting and stated that harvesting for Upper Long Lake, as opposed to using chemicals is the recommended approach for the reasons which include that it removes the nutrients from the lake water, harvesting encourages native plant growth. [] During the meeting this was very much supported by the participants, with the exception of Jim Joseph."

- 4. Thus the Lake Board, during its next business meeting in the summer, decided that access agreements were needed from all 3 launch sites permitting the utilization of harvesting equipment due to that threat. Legal expenses were and will continue to be an ongoing result of this process; and
- 5. \$31,767 for fighting the lake-wide invasive phragmites outbreak for three years.

These above unanticipated expenses and costs associated with inflation have depleted the whole reserve, driving our costs in 2012 to \$107,734, and used the last \$32,307 of our reserve. Ron presented copies of all expenses from 2005 to all who were present for review; no one was interested in the detail. One attendee stated that these documents are available on the Bloomfield Township website. (Note: Ron researched this after the Committee meeting and learned that SAD data is not available on the website.)

It was stated that by statute our SAD two year program requires a 10-15% contingency reserve. For example, an \$110,000 annual budget would be \$220,000 for two years. 10% of \$220,000 is \$22,000 and 15% would be \$33,000. Since our reserve is depleted it must be build back up to meet statute requirements to \$11,000-\$16,500 per year for the next two years. The Committee meeting attendees decided unanimously to build the contingency to the maximum amount of 15%. This served the purpose of avoiding an assessment-increase meeting in the near future. Building up the maximum reserve also allows for more flexibility in addressing unforeseen expenses, and it may allow a decrease in assessment rate when there are none.

**Lake Access Committee:** The Lake Board has requested that "Access Agreements" be developed for all three launch sites involved in harvesting, namely the Woods, Estates and the Shores. Once these are signed, the contract for the harvester will be signed by the Lake Board. This request was made to all neighborhoods by the Lake Board in August 2012. To date the Shores and Woods have signed and approved agreements in place. The Estates (where Lot 64 is located) has not. Jim Joseph, a Group C resident, handed out the 2002 Memorandum of Understanding to attendees and attempted to direct the

conversation frequently to his opinions on this document. The group reminded Jim that the Lake Board did not sign the document so a new agreement needs to be approved by the Lake Board. Jim Joseph, who is not a Committee member, nor a ULLE Board member, and spoke only as a non-riparian resident of ULLE reported that for this year, he wants harvesting to be done this year and the new agreement should be available in about two weeks.

The process of developing these agreements has exposed some issues with deed restrictions, incorporation documents and/or by-laws, which were or are being addressed. The Lake Board has notified each subdivision of their respective issues.

In terms of future legal costs to the Lake Board and SAD, the following are important considerations:

- 1. Since the Estates and Woods have a one year agreement, legal costs will continue into next year because of this.
- 2. Other unknown potential future legal costs to the Lake Board include a letter from ULLE resident Bill McMaster challenging the SAD assessment as being a tax.
- 3. A letter (which no one at the meeting was aware of or had seen) from Jim Joseph to Heron Bay and to Turtle Lake was interpreted by them as a threat to their access to the lake and precipitated litigation threats and retaining counsel. The Lake Board has become involved due to this letter, which increasing the costs to all SAD contributors. Jim Joseph did not provide this letter. All ULLE Group C residents in attendance were shocked and very much against Jim Joseph's unilateral actions.
- 4. The uncertain outcome of the Stephen Crane lawsuit vs. West Bloomfield Township, Bloomfield Township and the Lake Board.

Therefore, in terms of budgeting future legal expenses, the group decided to keep the 2013 legal budget at \$7,500, the same as 2012, however more could be anticipated. For the legal expenses that exceed this, there will be a cushion from the 15% contingency fund.

Some Lake Access Committee items carried over from 2012:

• Jim Whalen will continue to address the issue of allowing access to only those who have paid their access dues by developing a method to share the "who is paid" list between those who manage the keys to the three sites. He will discuss the following strategy with the three subdivision representatives: "If someone is paid at another site and the site is temporarily unavailable a paid member may get access to another site."

**Education and Association Cooperation:** A web site was started in 2008. Our web master is Chris Bonde. The website is <u>www.upperlonglake.com</u>. Various committee members and residents have contributed to the site.

The issue of fracking was briefly discussed. Ron brought the September 2012 "Oakland Lakefront" article and maps of well sites and leasable land in Oakland County. The group decided it was in the best interest of the lake to do an extensive benchmark water quality study called the "National Well Water Multiple Scenario Analysis, Test #779". The web site is (www.watertestamerica.com/national-well-water-test-parameters.html). It will study not only fracking chemicals but also 240 contaminants that affect drinking water standards. It will cost \$199.

- Ron will perform the sampling and distribute results on the web site
- Ron will ask Carol, his wife, to develop a fracking informational piece for the web site.
- Chris suggested residents go to the website to learn what has been included and to suggest what else needs to be done.
- Mike West volunteered to fill the ULLE website history of the lake section.

**Safety:** There were a few examples involving unsafe driving practices. They usually involved drivers or guests that are new to the lake. We are reminded that it is all of our own responsibility to address these issues immediately. The Oakland County Sheriff, Marine Division, can be called at 248-391-0256, if required. The following assignments are carry-overs from 2012:

- Jim Whalen to add an amendment to the "Water Safety on Upper Long Lake Rules" to Paragraph 7 titled "Drive Counter-Clockwise around the lake!!!!" to allow water skier and boarders to drive in a straight line ONLY in the middle of the lake to minimize wake for water skier ONLY when there are no other watercraft (motor or otherwise) on the lake (including non motorboats). Outside this exception the Michigan state law of counterclockwise path will rule will apply for all motorized boats.
- Jim Whalen to modify Paragraph 11 C of the Water Safety on Upper Long Lake Rules, to allow only known licensed competitive skiers to drive without an observer. Note Jim Whalen is the ONLY known licensed competitive skier in the lake at this time so he is the only person who is licensed to ski without a spotter.
- Eric will research deed restrictions to determine if there is any language related to allowing the sheriff access.

Chris has placed boating laws including 3 separate links on the Upper Long Lake web site: 2010 Water Safety on Upper Long Lake guidelines; The Handbook of Michigan Boating Laws and Responsibilities; State of Michigan Boating Rules and Registration.

#### Water Quality/Environment (Harvesting/Chemical/Biology):

 <u>Chemical:</u> In 2012 there was one treatment called by the Shores Canal Captain for both weed and algae control covering the whole Shores canal. The herbicide Reward was used to treat milfoil in the Shores. However, it is selective and allowed the coontail to proliferate, creating another problem. It was discussed that healthy, balanced lakes have a variety of species of lake flora. These plants keep each other in check by competing for space and resources. If one of them is removed (ie. by Reward) it can cause another weed to propagate and take over and create and unhealthy balance. This has been a constant theme presented at Michigan Lake and Stream Association, and is supported by Joe Lattimore, PhD Department of Fisheries and Wildlife, MSU. Dredging and the extra harvests reduced the need for further chemical treatment in the Woods and Estates canals.

Steve George stated The Shores residents are more environmentally and lake-health sensitive and are willing to rake any unwanted weeds themselves, which requires minimal effort and maintenance, and eliminates the need for chemical treatments. Since the Shores usually treats their canal for both algae and weeds for about \$3,600. The group agreed to carry this forward to

2013. Also the Estates or the Woods along the Square Lake section only sometimes asks for a partial canal algae treatment for \$700 to be carried forward to 2013. The \$800 permit fee is also required.

- 2. <u>Study:</u> Last year Steve George, took Secchi disc readings: it was an excellent year for water quality. Most readings exceeded 10 feet, to note the best recorded readings were 14'8" on April 6, 2012. The poorest readings were 4'6" readings on September 29, 2012. It was explained this excellent water quality was attributed to frequent harvesting and the lack of herbicides and toxins in the lake.
- 3. <u>Fertilizer</u>: No report.
- 4. <u>E-Coli</u>: No volunteers available to analyze e-coli in 2012, thus no analysis was done.
  - Ron to seek volunteers to do e-coli studies.
- 5. <u>Harvesting</u>: 1,096 tons were removed in 2012 with 3 lake harvests one special canal harvest for the Shores and two extra trimming twice for all three canals. The program for 2013will be similar to 2012. The predominant harvested weed is Chara (95%), which cannot be chemically controlled. The remaining 5% is primarily a combination of native milfoil and pond weed. Pond weed is a desirable plant and should never be chemically controlled. It was also discussed again at this point our biologically healthy lake has approximately 13 varieties of plants as studies by Karyn West and Eric Gleisner. The healthiest areas of the lake have multiple species represented. Although native milfoil can be chemically treated, it was decided the small percentage does not merit chemical treatment as it appears to be controlled by other competing plant life. The group decided that the 2013 budget should be \$80,000.
  - Eric and Karyn to bring plant survey to next meeting.
- 6. <u>6 Rivers Regional Land Conservancy.</u> It was discussed that there could be a possible benefit to becoming a member of this organization which is a part of the Friends of the Rouge.
- 7. (Carry Over) Mar Sclawy will request information and send it to Steve George to put membership fee into budget. (~\$50) web address: sixriversrlc.org

**Wildlife:** Steve has done frog surveys for seven years, and Karyn has done it for several years; both are signed up to survey again in 2013. The goose population seems under control on the lake but was a nuisance in the Wood's subdivision. Fishing is still very good. Since the goose management strategy of nest destruction and round up is working, we will continue for 2013 mentioning to do a better job in the Wood's area. In 2012 34 eggs were destroyed and 24 geese rounded up. There were also complaints about swans. The State of Michigan is investigating management of mute swans by introducing programs to be announced in several years. Jim Whalen suggested that we consider being a part of it when it happens because he reported 12 pairs of nesting swans on the lake and he felt that is too many. Many others agreed, but also noted that the more swans we have the fewer geese we have. Ron already requested a permit for egg removal because the deadline was April 1.

- 1. Ron will hire Goose Busters again. He will file all required permits, get permission from the Township, file an application and sign the contract.
- 2. (Carry Over) Steve, Karyn and Eric will inventory various wildlife around the lake during all seasons. For example the migratory birds, deer, geese, swans, mink, raccoons, etc. They may solicit help from various subdivisions. A report and pictures will be added to the web site.
- 3. Steve to publish frog survey results on web site and bring to next meeting.

**Lake level:** We reached the lowest recorded level this year at 15.25" as measured at the weir and Roger Cobb's guage. However during the summer we started at 36" as planned, but due to the scarcity of rain our lowest level on October 10, 2012, beating the record set on September 28, 1988 at 15.75". Dan Beresh has photographs that are on the web site taken in 1970 when the water was even lower, but not recorded.

• Ron will continue to monitor. We will contact Forest Lake Country Club who is reported to keep records of rain fall, lake water usage and lake levels also.

Current weir readings are 31 1/8", and the weir is set at 28". On April 15 it will be reset to 32" if levels are at or below 32". The target is for a June reading of 36", but Township officials insisted it be 34".

## **OLD BUSINESS**

**Woods Dredging Law Suit Update:** The Crane versus West Bloomfield, Bloomfield and the Lake Board was sent back to the Michigan Tax Tribunal because of decision favorable to Mr. Crane. It is now being placed on the Supreme Court docket for consideration. If Mr. Crane wins his case, the financial consequences to the Lake Board are not predictable at this time.

**Estates Dredging**: The Estates dredging project with the Lake Board is tabled. Jim Joseph reported that he wanted the subdivision to pursue its own solution. He said that he wanted the scope will be limited to the south end near the Roth's home and the dozen docks on lot 64. Jared said that he has some ideas about what to do with the dredged sand; it could be placed on his beach front. Jim suggested rebuilding the reed island's end using coconut logs like those being used on Island Lake. All the cost will be covered by ULLE residents and not the Lake Board, just like the two previous projects. Jim said he does not want to involve the Lake Board and the Woods residents agreed. Ron has a large file on dredging for ULLE and is willing to share at any time.

## • ULLE will keep the committee advised as plans progress

## Forest Lake Watershed Plan: No report

**By Laws:** The consensus of the group was to run the meeting as it has been for 30 years, that is without recorded By-Laws. But if there is any interest Ron remembers seeing an old draft somewhere in Roger Cobb's old files. He cannot guarantee finding it but he would look if there was interest. There was no interest at this time. Jim Joseph stated that he has experience in such matters if needed.

**Goose Management:** Same as previous years. Eggs and geese were rounded up by Goose Busters as in previous years. The group suggested the same plan and budget at \$800.

# • Ron to contract with Goose Busters to do egg collection and goose round up as we have done for the past decade.

**Phragmites:** To date we have spent \$31,767 on the non chemical removal of phragmites. 23 sites were treated in 2012 and some were eradicated. Every subdivision had at least one outbreak. The largest were the ULLE Island and three homes in Wabeek on Indian Summer Drive. The ULLE Island has shown great progress, many of the native plants are back and the phragmites population is about 20% of its worse condition. The residents who had their properties treated were very pleased. The discussion was brief. The group wanted to continue treatment to keep the outbreak under control. We spent \$12,267 in 2012. We will budget \$12,500 for 2013.

- Ron to update last year's letter to all ULL riparians for Leo Savoie's signature, wherein he will address all ULL riparians stating the Lake Board's intention for controlling phragmites around the lake and requesting permission and access of contractors to remove phragmites from private property.
- (Carry Over) Ron and Mike West to continue to research chemical/non chemical treatments and costs and benefits.
- (Carry Over) Karyn and Steve to examine and present the costs of new plants and costs maintenance of growing these plants and keeping them alive when chemical applications are utilized, vs the costs of the non-chemical approach.

Web Publishing: See Education and Association Cooperation section above.

ML&SA Annual Meeting and Membership: This is considered an important source of education and information so the group approved a budget of \$150 to continue our membership and \$550 for attending the meeting. Jim Joseph, Karyn West and Ron Cousineau expressed interest and will make their own arrangements to go. Karyn will volunteer to be the CLMP volunteer and attend those sessions. The Riparian magazine was not discussed but the group agreed to carry over the budget for all small items not discussed. This budget is \$100.

**Between the Lakes Issues:** Mike Losh, from Heron Bay, reported to Ron that we need to continue to harvest between the lakes. He has not noted any phragmites on the channel. Many of us have seen a very large outbreak on Lower Long Lake and Ron notified the Lake Manager and Terry Counihan, the president of the Forest Lake, Island Lake and Lower Long Lake Association. They have no plans to manage it at this time. It should not affect our lake.

#### **NEW BUSINESS:**

**2013 Harvesting Contract**: There is no contract signed yet for lake harvesting. The Lake Board is waiting for the ULLE access agreement. Eric has held some dates for harvesting our lake. The dates are as follows: May 13 - 22, June 20 - July 2 and September 3 - 16. There basically is no change in the contract language for the past many years except this year it will have access agreements added to his contract from the Woods, Estates and Shores. The 2013 budget is the same as 2012 at \$80,000 for 3 lake harvests at \$22,500 each, one separate canal harvest at \$3,500 each and six canal extra trimming at \$1,500 each. The trimming reduces the need for chemical treatments. Steve George reported that nothing has changed since 2012 when the Woods decided not to be a harvesting site for any part of the lake.

**2013 Chemical Contract:** Aqua Weed chemical control has presented a contract that is similar to the past few years. New this year they also, by a request, submitted a proposal for Sonar treatment of milfoil. Earlier in the year, Jim Joseph and Roger Cobb (two ULLE Group C residents) requested a quote from Ron for treating the entire lake with SONAR. SONAR is the brand name for floridone, an herbicide. Subsequent to Jim Joseph and Roger Cobb's request, Ron called Aqua-Weed to do a survey of the lake, and a quote for 2013 for SONAR. Aqua Weed reported that SONAR would address the milfoil patches present in the lake, which represents 5% of the lake weed population. However, the predominant weed in our lake is chara, which is not effected by SONAR. Weed control with SONAR lasts approximately one year.

The first year costs involve a floridone study required by state of Michigan, and the use of numerous other chemicals, including Reward, Renovate, copper based products, and 2-4D to pre-treat the areas. The second year, we would treat with floridone. The 3<sup>rd</sup> year an additional study is required to assess the treatment, and further chemical treatments are required. The total cost for 3 years of treatment is would be \$20,000, plus additional chemicals costs for the remaining 2 years (which is an unknown). Ron and Eric pointed out that 3 harvests would still be needed anyway as 95% of our weeds are chara and SONAR does not cover chara. Eric added that he disposes of our weeds in an organic farm environment; if we treat our lake with chemicals it will be difficult for him or any harvester to find a dump site without greatly increasing overall harvesting costs.

Ron mentioned that we used Sonar for six years and for those years Wittbold harvested 290 tons of weeds from the lake. In the other 10 years that Wittbold harvested when chemicals were not used he averaged 290 tons per year. The reason being that chara is our predominant weed and it cannot be controlled throughout the lake with chemicals. The net result was that there was no positive impact from the chemical use except that the kinds of weeds that grew back were not milfoil but curly leaf pond weed at nuisance proportions and other native plants. We have rarely spot treated the mouth of canals when the milfoil became so thick that it required treatment beyond what harvesting could do. We do not have Eurasian milfoil but a hybrid variety which acts more like native milfoil.

This elicited a lot of emotional discussion. Many residents the meeting were shocked at this request for SONAR treatment and extremely upset at the concept of treating our all-sports lake with SONAR. Many had very strong feelings against using any chemical treatments on our all-sports lake where they and their children swim, or water their lawns and landscaping. Residents did not support this SONAR or other chemical treatment. There was unanimous support against use of SONAR on our lake, with the exception of Jim Joseph. The group was questioned about their thoughts related to whole lake chemical treatments and the response was emotional and unanimous – "Never use whole lake treatments". The group was surveyed about occasional spot treatments when necessary and only about 20% said yes. So the program is a carryover at \$800 for the permit, \$3,600 for Shores whole canal treatment and \$700 for as required algae treatments in the canals.

• Ron has forwarded the contracts with Aqua-Weed for chemical treatment for 2013 to the Lake Board for signature. This will include permission for phragmites treatments for residents who prefer this method on their property.

**Fish Study:** For approximately 5 years there have been numerous requests for a fish consumption study. The group did not approve any funds this year.

• Mike Haddow to research alternatives and present a cost estimate next year. Those attending the ML&SA conference, which is featuring fishing, should research fish consumption consultants.

**Professional Management and Studies:** Lake Pro wrote that last year's quote is still valid for this year. The group will postpone professional management of harvesting and the lake until our funding issues settle down, even though the neighboring lakes have hired Lake Pro for about \$5,000 worth of services. Lake Pro would be willing to develop a request for quote for harvesting to submit to the Lake

Board for \$400. The group approved it. It was decided that we would rely on volunteers to do e-coli studies using Oakland County Health or 3-M home testing kits. We will budget \$200.

## • Jim Whalen and Steve George will investigate Oakland County Health for e-coli studies or they will contact Ron who has a source for home testing kits from 3-M.

**2013 Plan and Budget Submission to Lake Board:** Ron developed a draft set of options "Same Fee" vs. "Economy" vs. "Continue the Same", which was part of the agenda document provided prior and during to the meeting) and attendees and committee members kept track of the decisions that were made during the meeting. The attached Plan and Budget records the group's consensus based on the discussions noted throughout the meeting. The off lake assessment would become \$160 and the riparian assessment would become \$640. The Lake Board runs on 5 year plans, and the total budget addressed is for the last 2 years (2013 and 2014) of this current 5 year plan. The total budget for these next 2 years is \$130,400 annually. There was a lot of discussion about this higher assessment and the group unanimously approved it, including the proxies. It will rebuild the contingency fund and basically do what we have been doing for the past three years.

The next 5 year plan (2015- 2019) most likely we will not have to raise the rates and possibly even lower them as the contingency fund will have been brought up the statutory limit. The next plan would include performing the same lake services, and more lake services: including fish consumption study; and hiring a lake manager to respond to the other tabled lake issues which have been presented in prolific manner this past year by a couple individuals.

When the legal fees reduce and the phragmites become more in control we will be able to hire a professional lake manager, which will tend to reduce many management issues related to harvesting and chemical usage. We should be also prepared to study the water quality and safety for fish consumption which we have been neglecting. In the meantime, Steve George, Eric Gleisner, Denis Parks, Ron Cousineau and Karyn West will continue to do volunteer work for lake health and water quality by themselves, such that we do not need to hire and invest financially in consultants to do the same work at this time. The \$640 is 75% of the average of Lower Long (\$804.58), Forest Lake (\$773.87) and Island Lake (\$998.54). All three of them harvest three times and have a professional manager.

There was discussion on any potential impact of raising assessments \$240 for riparians and \$60 for lake access residents. Prior to the meeting Ron received direct feedback from approximately a dozen residents. Of these 10 supported the SAD increase, and 2 claimed financial hardships stating raising their assessment \$60 (as they were non-riparians) would be financially detrimental to them. However it was stated in the meeting if a resident cannot pay the annual increase, this would create a non-foreclosable lien on their property and deducted from their home when sold. It was discussed, that the neighborhoods themselves could address helping out other neighbors who are in financial distress and cannot accommodate the fee increase, or they could start a fund for such neighbors within their neighborhood. This would not be a Lake Board issue.

If the Lake Board accepts our proposed 2013 Plan and Budget (which would cause an increase in our SAD assessments) then the Lake Board will call a public hearing. All SAD residents will be notified in advance via first class mail by the Lake Board.

- All Committee members to contact their associations about the recommended rate increase which will have to go to the Lake Board for approval and inform residents of this issue, educate residents on why, and advise them on the likelihood of this happening.
- Steve George and Jim Whalen to attend the Woods annual meeting in early April and present this issue.
- Ron will contact ULLE and the Shores with an update.
- Ron to advise committee of future Lake Board meetings.
- Ron to submit 2013 Plan and Budget as developed during this meeting to Lake Board. (see attached)

Letter to Lake Board: Bill McMaster, a ULLE non-riparian resident, sent a 7 page letter dated March 19, 2013 to Leo Savoie and ULLE acting-President Amy Monroe requesting information under the Freedom of Information Act. He requested information including: the Woods dredging; the ULLE response to Ron's e-mail "Our Lake Management Fund if Out of Money"; the Memorandum of Understanding dated 2002; and ULLE deed restrictions. In Mr. McMaster's opinion, a SAD assessment is a tax, and therefore subject to the Headley Amendment. According to the township attorney there is a legal distinction between a tax and the SAD assessments, and Mr. McMaster is in error in his opinion. The cost to the Lake Board to consult with counsel, who responded to Mr. McMaster's letter, was paid for by our SAD fund. This issue was also addressed on page #4 of these minutes.

## Water Safety on Upper Long Lake

To promote safe and responsible boating on Upper Long Lake, the Safety Committee of Upper Long Lake has summarized key elements of the law and guidelines from the Department of Natural Resources & Environment' booklet, "Handbook of Michigan Boating Laws & Responsibility" (for full brochure: www.boat-ed.com/mi/handbook/index.htm)

Although an Upper Long Lake Patrol has been formed to encourage water safety and responsibility by advising offenders about the law, it is *everyone's* responsibility to know and abide by the state laws and common courtesy. **IT IS ESPECIALLY IMPORTANT TO REVIEW THESE LAWS AND RECOMMENDATIONS WITH BEGINNING BOATERS AND YOUR GUESTS.** 

#### Have a safe and fun water sports season on Upper Long Lake!!

#### **Rights to Operate Boats:**

- 1. <u>State Registration</u>: All power boats (including jet skis) and sailboats of 12 feet or longer, as well as rowboats of over 16 feet, must be registered with the State of Michigan.
- 2. <u>Lake Registration</u>: Upper Long Lake's Associations require all boats to be registered with respective subdivision associations to assure control of boat population.

#### Usage of Boats

- 1. Because this is a private lake, only land owners may have permanent watercraft on the lake. These watercraft should only be used by the deeded property owner and their immediate family, domestic servants and <u>day</u> guests.
- 2. Upper Long Lake Property owners can allow access for guest's watercraft but these boats may only be operated on a day use basis from sunrise to sunset. Watercraft that are not owned by ULL property owners are not allowed to be moored or docked overnight.
- 3. We have also had problems with marinas that have keys to some of the launches on the lake and they are sneaking non owner boats on the lake.

#### **Invasive Species**

Residents are asked to take great care to inspect all watercraft, docks, hoists, etc. for zebra mussels and other invasive species. This is especially important if these items are coming from another body of water. Please take all the necessary precautions to inspect and sanitize any of these items thoroughly.

#### Lake Boat Launch Access

There are only three launches on the lake, located in Upper Long Lake Woods, Upper Long Lake Shores and Upper Long Lake Estates. If you don't live in one of these subdivisions, you can contact the individual subdivision association for access privileges. There is usually an annual fee for this service

#### Swimming:

- 1. <u>Swimming Areas</u>: Swimming is allowed only in designated swimming areas by subdivision rafts, within authorized swimming buoys; with 100 feet of shore; and within 100 feet of an anchored boat.
- 2. <u>Swimming Supervision</u>: Children under ten should be supervised by a competent adult or responsible older swimmer. It is unwise for <u>anyone</u> to swim alone.

#### Motor Boat Rules of Operation (Includes jet skis):

- 1. Don't Overload Boats.
- 2. <u>Be In Control:</u> A person under the influence of alcohol, or a controlled substance, shall not operate a boat.
- 3. <u>Drive Safely:</u> Drive so as not to interfere with the lawful use of the lake by others.
- 4. <u>Speed:</u> Due to lake size and boating population, the maximum speed unit is 36 MPH during daylight hours. A maximum speed from dusk to dawn is 7 MPH.
- 5. <u>Jet Skis:</u> Since jet skis do not have lights, and must go faster than 7 MPH, it is unlawful to operate them from dusk to dawn. You must be over 14 years old and have a boating certificate to operate a jet ski. Under 14, you must be accompanied by an adult. See State of Michigan Boating Handbook for details.
- 6. <u>Be Mature Enough:</u> Boat drivers less than 16 years old must be accompanied by at least one person 16 years or older, unless they are at least 12 years old and have a Department of Natural Resources Boating Safety Certificate. (See state of Michigan Boating Handbook).
- 7. Drive Counter-Clockwise around the lake!!!
- 8. <u>100 Foot Rule:</u> Drive and ski to maintain a safe distance of 100 feet from all person and property (swimmers, rafts, fishing boats at anchor) except a "slow no wake speed."
- 9. <u>Right of Way</u>:
  - a. Slower boat traffic should stay closer to shore
  - b. Overtaking Pass to port (left) of slower boat.
  - c. Sailboats and Unpowered Boats These have right of way over motorboats.
- 10. <u>Accidents:</u> In case of accident involving \$100 or more damage, report details to the owner of the damaged property immediately, and within five days, to the Oakland County Sheriff's Department, Marine Division at (248) 391-0256. Additionally, if injury is involved, render reasonable assistance to the victim.
- 11. Water Ski Rules (Tubing, Kneeboarding, Wakebaoarding etc.):
  - a. Ski Safely Ski in a manner that does not endanger any person or property.
  - b. Hours Permitted By law, you may ski one hour before sunrise through one hour after sunset. **However**, courtesy suggests that you start no earlier than 8:00 a.m., or when light conditions allow good visibility, and lakeside neighbors are probably awake.
  - c. Observer At least one competent observer needs to accompany the driver.
  - d. Mirror All ski boats must have at least a 170-degree wide-angle mirror to assist driver in observing skier.
  - e. Overtaking Rule Remember that slower boats should stay closer to shore, and the overtaking passes on the port (left) side of the slower boat.
  - f. Wakeboard boats often have larger wakes than runabouts, especially when using the optional ballasts and other wake enhancing options of these boats. Please be aware of your wake especially in close proximity to canoes, kayaks and other small watercraft. Shoreline erosion is an ongoing problem on our small lake. Again, common courtesy would dictate proper operation of boats that produce large wakes.

- 12. Additional Ski Course Permit Provisions: (See separate brochure for ski club rules)
  - a. It is open to the general public. If you use it often, consider joining the Upper Long Lake Association Ski Club, and help pay for its upkeep. The permit is held by Stephen George, 248-535-0444.
  - b. The ski course should only be used when no other boats are on the lake, usually in the morning hours. It has been a common practice for over 30 years that skiers take turns using the course to assure calm water for all skiers. If someone comes out and wants to wakeboard and/or jet ski, courtesy would suggest that these people talk to each other and share the lake in an appropriate manner. If more than 2 boats are on the lake at the same time, it would not be advisable to use the ski course.
  - c. It is unlawful to moor or fasten a boat to a lawfully-placed buoy, or to remove or damage such a buoy. If you accidentally damage a water ski buoy, make restitution to the Upper Long Lake Association Ski Club. If you damage a ski buoy, contact the Ski Club, Jim Whalen, 248-333-0414.

## Scuba Diving and Snorkeling:

- 1. Scuba diving and/or snorkeling are not recommended in such a small lake except within 100 feet of shore.
- 2. When scuba diving, place diver's flag (red rectangle with a diagonal white stripe) at center of dive on buoy. Divers must stay within 100 feet of flag. Boaters must stay at least 100 feet from the flag.

## Liability:


Registered owner will be liable for all personal or property damage occasioned by the negligent operation of his/her watercraft (personal injury, shoreline damage, property damage) by anyone.

### Required Safety Equipment: (See Michigan Boating Handbook for Complete Rules

- 1. <u>All Boats:</u> One accessible Type I, II or III personal flotation device (PFD) is required for every person on board. You are required to have one life jacket for each person on board your watercraft.....and they must be of appropriate size to fit the passengers on board each specific watercraft.
- 2. All Boats 16 Feet or Longer:
  - a. One throw able Type IV PFD is required in addition to one PFD for each person.
  - b. One handheld mouth whistle or power horn, capable of being heard for ½ mile is required.
- 3. Motorboats Less Than 26 Feet:
  - a. One Type B-1 (2 lbs. of dry chemical) fire extinguisher is required.
  - b. One white light aft, and a combination red port and green for starboard light on the bow, visible when operating between sunset and sunrise, are required.
  - c. A muffler that assures noise emissions lower than 86 decibels (similar to the noise of a passenger car at the same speed) is required.
- 4. <u>Non-Powered Boats (Canoes, Rowboats, and Sailboats)</u>: One white light lantern, when on lake between sunset and sunrise, is required.
- 5. <u>Inboard Motorboats:</u> Must have a backfire flame arrester.

## Fishing:

- 1. Respect fishing boats. Keep as much distance from them as possible, at least 100 ft.
- 2. Skiers are to stay out of reserved fishing areas when fisherman are present, and stay in the ski lanes.
- 3. Fishing boats are to stay out of ski lanes on heavy traffic days. Reserved fishing areas are designated on the attached map.
